The range of services includes psychiatry, pharmacy, counseling, case management, and primary care. Extended support services include programming that emphasizes nutrition, fitness, and social recreation.

4b (Code: ) (Expenses \$ 12,758,825. including grants of \$ 1,741,905. ) (Revenue \$ 1,727,440. ) Preparing for Success at School and in Life The Centers provides early learning programs through the Early Head Start, Head Start, and Universal Pre-Kindergarten programs. It provides early learning programming at six centers across Greater Cleveland and through a comprehensive home-based services team. In 2014, The Centers prepared 1,300 young children to enter kindergarten poised for success. Additionally, the Centers recently launched its 2,000 Days Pledge initiative to establish a framework for engaging parents, teachers, and communities to make a child's first 2,000 days-the time when 90% of brain development occurs-as impactful as possible.
